TO PREVENT ANY CONFUSSION THEY WERE INSTRUCTED THAT ANY ELECTRIC PROD USE MUST BE ONLY ON THE BACK OF THE ANIMAL. SIGNED TRAINING FORM IS ATTACHED.

THE LIVESTOCK FOREMAN WILL KEEP A CLOSE EYE ON EMPLOYEES WHEN THEY ARE USING AN ELECTRIC PROD. ON OUR WEEKLY HUMANE

HANDLING AUDIT WHERE WE CHECK FOR ELECTRIC PROD USE WE WILL ALSO CHECK FOR IMPROPER USE OF PROD AND FOR THE NEXT WEEK IT WILL BE CONDUCTED DAILY, IF ALL ACCEPTABLE WE WILL CONDUCT THE AUDIT TWICE A WEEK FOR AND ADDITIONAL MONTH. IF AFTER THAT MONTH WE FEEL COMFORTABLE THAT EVERYONE IS PROPERLY USING THE ELECTRIC PROD WHEN THE PROD IS THE LAST RESORT THEN WE WILL RESUME OUR NORMAL ONCE A WEEK HUMANE HANDLING AUDIT. WE WILL ALSO MAKE THE TRAINING GIVEN TODAY PART OF OUR ANNUAL TRAINING TO GO ALONG WITH OUR "ROBUST SYSTEMATIC APPROACH TO HUMANE HANDLING PROGRAM".

DEVIATIONS WILL BE INDICATED WITH AN X OVER THE NUMBER OF HOG BEING CHECKED.

IN THE EVENT THAT THERE IS IMPROPER PRODDING, THE EMPLOYEE WILL BE SUSPENDED. IF THE EMPLOYEE IS BROUGHT BACK AFTER SUSPENSION, THE LIVESTOCK OR EXECUTION HALL FOREMAN WILL SHADOW THE EMPLOYEE FOR ONE WEEK.
